**Jackpot Conditions**

- Open to any horse/rider combination – EFA registered and non-EFA registered.
- Open to both horses and ponies.
- Open to Senior and Junior riders.
- Riders must be members of EFA, CDA or have CDA day membership.
- Official horses may not compete at a level lower than their official grading level.
- Unofficial horses may only win 4 Jackpot class at the same level (eg Novice) before they are then no longer eligible to compete at that level of Jackpot or lower.
- Official judges will be used for the competition.
- Entries limited to the first 30 nominations received (reserves will be taken in case of scratchings)
- Jackpot Scores will not eligible for CDA Leaderboard.

**General Conditions of Entry**

- EFA Rules Apply
- All events open to horses and ponies, placings and prizes will be separate for horses and ponies (except Jackpot class)
- **ALL WORKERS will be paid \$5.00 per hour**
- Biosecurity procedures must be followed
- No refunds after close of entries unless vet / medical certificate supplied.
- In case of cancellation an administration fee of 20% may be retained by the organising committee of the club
- If less than 4 riders in any class prize money may be half.
- Each horse and rider combination may only compete in a total of 3 classes in two consecutive levels on any one day.
- # Are also QISEA qualifying classes – QISEA riders must include a photocopy of their performance card with their nomination form to verify their membership and number
- HC entries must be declared in writing to the organising committee prior to the start of the competition and for official competitions must carry correct EFA registration.

- HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the club/coach, participants, EFA and its state bodies or any subdivision thereof, officials, volunteers, medical personnel, any persons, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the EVENT(S), premises and event inspectors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and each of them, their directors, officers, agents and employees, all for the purposes as herein referred to as "Releasees", FROM ALL LIABILITY, TO THE UNDERSIGNED, his/her personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
