## **CONDITIONS OF ENTRY:**

1. This event will be conducted in strict accordance with the rules of the EFA and/or the FEI and ALL D.P.I. regulations.
2. Entry fees must accompany entry form, as must a TRAVELLING HORSE STATEMENT.
3. Current safety approved helmets AS/NZS 3838 must be worn at all times by all riders.
4. Gloves to be worn at all levels (Official and Associate).
5. Official horses may be ridden in two consecutive levels but no more than three tests (which may include a free style) on any day, e.g., two official tests and one associate or two associate and one official test.
6. No horse may compete below its current grading in official or associate events, except HC at any level.
7. HC entries will be accepted at the time of nomination at normal entry fee.
8. Official horses must be registered with the EFA and have a current grading card.
9. Associate horses may be of any height and riders of any age.
10. Associate riders must be at least an Associate Member of the EFA or a member of SDC Inc. - day membership of SDC is available.
11. Juniors are 16 years of age and under on the day of the event.
12. Tests may be commanded except at FEI level.
13. ALL COMPETITORS MUST HAVE APPROPRIATE DOCUMENTS TO BE SENT WITH ENTRIES.

## **Cancellations:**

If this event is cancelled or postponed, 20% of the entry fee will be retained to cover costs. There will be no refund of money after the closing date of entries, except on production of a Veterinary or Doctor's Certificate within 14 days after this event - then only 20% will be retained to cover club costs. In consideration of the SDC Inc accepting an entry, riders and/or owners will undertake NOT to hold the committee or members of the SDC Inc responsible for any claims, losses, suits or damages. All riders and/or owners should fully understand that they compete at their own risk. Your signature on the entry form confirms that you understand and accept the conditions of entry.

**STABLES: Good but limited and will be allocated in order of receipt of entries, although preference will be given to FEI and visiting horses - \$10 per night. Good yards available.**

**CAMPING: \$15 per site to be paid with entry.**
