3. Only horses nominated to compete with the relevant DPI&F paperwork may enter the grounds.
4. No refunds after close of entries without a Vet or Medical Certificate.
5. Riders must be EFA Associate or SEG members. Horses need not be registered with the EFA, but if they are, they must compete at their graded level or HC
6. If the event is cancelled the club may retain \$2.00 per ride
7. Hacking jacket optional, shirt and tie or ratcatcher acceptable.
8. Limit of 25 riders per class (reserve list may be established)
9. Maximum of 2 horses per rider; maximum of 3 tests per horse over 2 consecutive levels
10. Tests and Ribbons can be sent home at a cost of \$2 per address. (Prize money is not posted!)

HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the club/coach, participants, EFA and its state bodies or any subdivision thereof, officials, volunteers, medical personnel, any persons, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the EVENT(S), premises and event inspectors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and each of them, their directors, officers, agents and employees, all for the purposes as herein referred to as "Releasees", FROM ALL LIABILITY, TO THE UNDERSIGNED, his/her personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
